The first of Italy's new energy storage capacity procurement auctions (MACSE) will take place on September 30, , Terna's president for grid development strategies, Francesco Del Pizzo, has confirmed. How much does energy storage cost in Italy? Namely, according to the updated scenario developed by gas company Scam and power grid operator Terna, Italy will need 72 GWh of storage capacity by to meet the EU's "Fit for 55" package goals. Around 50 GWh of this capacity will be allocated to new utility-scale systems supported by MACSE to complement the growing penetration of renewables. How will MACSE change energy storage requirements in Italy? There are stark differences in energy storage requirements across Italy and MACSE procurement targets will adapt to these zonal needs. Most of the new utility-scale storage capacity catalyzed by MACSE will be needed in Southern Italy and the islands, with 16.8 GWh in the South, 13.6 GWh in Sicily, and 10.4 GWh in Sardinia. How much storage capacity does Terna need for ? Terna has identified a target of 10 GWh of additional storage capacity for to be financed through MACSE.
