All procurement follows the European Spallation Source ERIC Procurement Rules, which align with the EU treaty principles of transparency, non-discrimination and competition. Is eInvoicing a public-procurement regulation in Hungary? The regulation on eInvoicing in Hungary is not public-procurement specific. Use as baseline, the Act CXXVII of on Value Added Tax states that invoices can be printed or issued electronically. Can invoices be issued in Hungary? Invoices in Hungary can still be issued using printed invoice forms or an invoicing program (or cash register). However, data on invoices issued from the block (or invoicing program) must be disclosed to the RTIR System. Manual invoice data must be entered in the online invoice system (Szmla platform).
