



How is State Procurement carried out in the Republic of Azerbaijan? 16.1 State procurement of goods (works) and services in the Republic of Azerbaijan is carried out using the methods of open tender, two-stage tender, limited participation tender and closed tender, request for bids, request for quotations and procurement from one source, depending on the conditions of use noted in Clauses 17-21 of this Act. This Law defines the economic, legal and organizational basis for government procurement in the Republic of Azerbaijan, establishes the principles and rules for the rational and economical use of state funds during procurement, creating an equal competitive environment for all suppliers (contractors) on the basis of competition and publicity. What is the rule of assessment of influence in Azerbaijan? The rule of assessment of the influence of the cases specified in Article 422 of the Republic of Azerbaijan is confirmed by the body (institution) defined by the conforming Executive Authority.
