Can foreigners invest in battery storage businesses in Brazil? Investment, incentives and taxation scenarios According to Brazilian law, there are no legal restrictions on direct foreign investment in the battery storage businesses or in the power sector (except in very specific segments or sectors of the economy). What are the rules governing direct purchasing in Brazil? Strict rules apply to direct purchasing which expose the public officer responsible for the purchase to personal liability. Brazilian suppliers may also enter into consortia (consórcios) to bid on specific tenders. Under Brazilian law, consortia are regarded as contractual joint ventures. What is a PPP in Brazil? The PPPs Law has made Brazil's strict government procurement procedures more flexible and investor-friendly. There are two types of PPPs: administrative concession (concessão administrativa), whereby the private concessionaire only receives the agreed payments from the public partner. Do government-owned companies need a public procurement process? This statute allows government-owned companies to enter into strategic partnerships with the private sector with no requirement to launch a prior public bidding process. Pursuant to the Brazilian Federal Constitution, public procurement rules are mandatory for all entities controlled directly or indirectly by the government. With the coming into force of the Public-Private Partnerships Law in late 2015, public-private partnerships ("PPPs") became an alternative for foreign investors wanting to take part in large projects in Brazil.
