



What is a sustainable public procurement? In a sustainable public procurement, you not only consider the benefits arising for your own organisation, but look at society as a whole. At the same time, you minimise environmental damage and safeguard certain social aspects such as equitable working conditions. How is procurement regulated by public authorities? Procurement by public authorities is regulated in the Public Procurement Act, the Utilities Procurement Act, the Act on Procurement of Concessions, and the Defence and Security Procurement Act. Several of the provisions in these acts implement the provisions of the procurement directives. Can a group of suppliers satisfy the requirements on economic and financial standing? The contracting authority may state in the procurement documents how a group of suppliers shall satisfy the requirements on economic and financial standing in the meaning of Chapter 14 Sections 3 and 4, or technical knowledge and professional experience in the meaning of Chapter 14 Section 5, if this is justified for objective reasons.
