How does Ghana's e-procurement system function? Ghana's e-procurement system functions using the Open Contracting Data Standards (OCDS) for reporting and display of information. In this format, information is available at each stage of the procurement process. How does the procurement process work in GHANEPS? The procurement process in GHANEPS starts with planning. Entities are required to draft an annual procurement plan, which must be approved by the Entity Tender Committee by the end of November for the subsequent year. Quarterly updates of these plans are also required, and the plan must be uploaded on GHANEPS. What is a public procurement system? The system supports various public procurement procedures including user registration, tender notification, tender preparation and submission, online tender evaluation, contract awarding, creation and management of catalogue, creation and management of framework agreements and auctions and payments.
