What is public procurement law in South Africa? Section 217 of the South African Constitution grounds public procurement law in South Africa. This section mandates that when an organ of state in the national, provincial, or local sphere of government, or any other institution identified in national legislation, contracts for goods or services, it must do so following a system that is: What are the requirements for procurement in South Africa? (5) A procuring institution must stipulate in the bid documents, irrespective of the procurement method, that bidders may only quote in South African currency, inclusive of all applicable taxes.
