How much should you budget for employment in Portugal? Are social security contributions compulsory in Portugal? Pensions and social security contributions are compulsory in Portugal and are administered by the Ministry of Labour, Solidarity, and Social Security. Employers are required to pay a payroll contribution equal to 26.5% of an employee's wages while an 11% social security tax is deducted from each employee's paycheck.

How do payroll taxes work in Portugal? Payroll taxes in Portugal consist of a combination of social security contributions, income tax withholdings, and other deductions mandated by law. Employers and employees are responsible for contributing to the country's social security system, which funds pensions, unemployment benefits, healthcare, and family allowances.
