The State supports development funding through a number of different State agencies, including: Home Building Finance Ireland (HBFI): green funding. Ireland Strategic Investment Fund (ISIF): elements of social housing. Land Development Agency (LDA): cost rental housing. Housing Finance Agency (HFA): student accommodation. How are Irish rent regulations affecting residential funding & investment? Residential funding and investment continue to be impacted by the restrictive Irish rent regulations, with a 2% rent cap increase for private rental sector and student housing as a result of the Rent Pressure Zone (RPZ) regime in place. Which European cities are a target for multifamily/PRS investment in ? Fundraising momentum continues, with a clear emergence of core funds dedicated to living sector assets, expected to grow throughout . Dublin ranks among the top five target cities for Multifamily/PRS investment across Europe, as highlighted by Knight Frank's European Living Sector Survey. What will Ireland's new funding entail? The new funding will be focused on the introduction of new primary radar systems to identify aircraft in Irish skies as well as sonar equipment to detect objects under the sea. There will also be investment in new armoured personnel vehicles to provide force protection for troops. How much exchequer funding is available for housing in ? Total exchequer funding available is EUR4.85bn, made up of EUR3.2bn Capital and EUR1.65bn Current. The Government has committed a EUR6bn capital investment in housing for made up of exchequer funding, EUR1.25bn allocated to the Land Development Agency (LDA) and EUR1.65bn for the Housing Finance Agency (HFA).
