The lowest accepted bid was EUR0.07199/kWh for a 2.7 MW solar plant in the province of Ancona, central Italy. How many MW of solar power will Italian authorities allocate? Italian authorities expect to allocate more than 600 MW of solar photovoltaic capacity through the auction. "The data confirm excellent participation in photovoltaics and a trend consistent with expectations for wind power," said Italian Energy Minister Gilberto Pichetto Fratin. Terna calculated the storage needs by balancing two factors: how much renewable energy would otherwise be wasted (valued at natural gas plant costs) and how storage improves grid reliability (valued at EUR8,000/MWh yearly for 4-hour systems).
