Does Enterprise Estonia offer large-scale investment support? Enterprise Estonia has opened the application round for large-scale investment support. The incentive, created by the Ministry of Economic Affairs and Communications, aims to accelerate projects with investment volumes exceeding EUR100M. How does Estonia benefit from external grants? Private investment declined sharply at the time of Estonia's economic crisis, from 37.5 percent of GDP in 2007 to 21 percent in 2009, and is yet to recover fully. At the same time public investment was kept high, and its contribution to total investment grew from 13 percent in 2007 to a peak of 24 percent in 2009.
